

Fund description and summary of investment policy

The Fund invests primarily in shares listed on the Johannesburg Stock Exchange (JSE). The Fund can invest a maximum of 30% offshore, with an additional 10% allowed for investments in Africa outside of South Africa. The Fund invests the bulk of its foreign allowance in equity funds managed by Orbis Investment Management Limited, our offshore investment partner. The Fund is typically fully invested in shares. Returns are likely to be volatile, especially over short- and medium-term periods.

ASISA unit trust category: South African – Equity – General

Fund objective and benchmark

The Fund aims to create long-term wealth for investors. It aims to outperform the average return of South African General Equity Funds over the long term, without taking on greater risk of loss. To pursue its objective the Fund’s portfolio may differ materially from those of its peers. This will result in the Fund underperforming its benchmark materially at times. The Fund aims to compensate for these periods of underperformance by delivering outperformance over the long term. The Fund’s benchmark is the market value-weighted average return of funds in the South African – Equity – General category (excluding Allan Gray funds).

How we aim to achieve the Fund’s objective

We seek to buy shares offering the best relative value while maintaining a diversified portfolio. We thoroughly research companies to assess their intrinsic value from a long-term perspective. This long-term perspective enables us to buy shares from sellers who over-react to short-term difficulties or undervalue long-term potential. We invest in a selection of shares across all sectors of the stock market, and across the range of large, mid and smaller cap shares.

Suitable for those investors who

- Seek exposure to listed equities to provide long-term capital growth
- Are comfortable with stock market fluctuation, i.e. short- to medium-term volatility
- Are prepared to accept the risk of capital loss
- Typically have an investment horizon of more than five years
- Wish to use the Fund as an equity ‘building block’ in a diversified multi-asset class portfolio

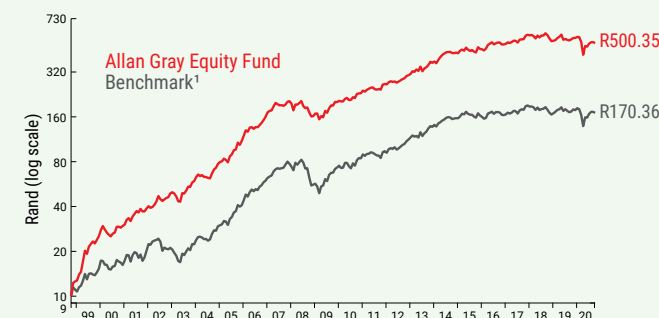

Meeting the Fund objective

The Fund has created wealth for its long-term investors. Since inception and over the latest 10- and five-year periods, the Fund has outperformed its benchmark. The Fund experiences periods of underperformance in pursuit of its objective of creating long-term wealth for investors, without taking on greater risk of loss than the average equity fund. The maximum drawdown and lowest annual return numbers, in the 'Performance net of all fees and expenses' table, show that the Fund has successfully reduced downside risk in periods of negative market returns.

Annual management fee

Allan Gray charges a fee based on the net asset value of the Fund excluding the portion invested in Orbis funds. The fee rate is calculated daily by comparing the Fund's total performance for the day to that of the benchmark.

Fee for performance equal to the Fund's benchmark: 1.00% p.a. excl. VAT

For each annualised percentage point above or below the benchmark we add or deduct 0.2%. The maximum fee is uncapped and if the fee would have been negative, 0% will be charged for the day and the negative fee will be carried forward to reduce the next day's fee (and all subsequent days until the underperformance is recovered).

This means that Allan Gray shares in approximately 20% of annualised performance relative to the benchmark.

A portion of the Fund may be invested in Orbis funds. Orbis charges performance-based fees within these funds that are calculated based on each Orbis fund's performance relative to its own benchmark. Orbis pays a marketing and distribution fee to Allan Gray.

Total expense ratio (TER) and Transaction costs

The annual management fees charged by both Allan Gray and Orbis are included in the TER. The TER is a measure of the actual expenses incurred by the Fund over a one and three-year period (annualised). Since Fund returns are quoted after deduction of these expenses, the TER should not be deducted from the published returns (refer to page 4 for further information). Transaction costs are disclosed separately.

The FTSE/JSE All Share Index (ALSI) is up marginally for the quarter and now only slightly lower than where it started the year. This is after being down as much as one-third for the year at the lowest point in March. It may seem counterintuitive that the market has recovered its earlier losses given the deteriorating economic picture. For example, the South African Reserve Bank is now forecasting an 8% contraction in GDP for 2020.

The recovery in the market has not been even. The resources sector and selected industrial companies have performed well, while share prices of financials and domestically focused industrials are significantly below where they started the year.

Gold and platinum mining companies have benefited from higher prices of precious metals and the weaker rand, which translates their revenue at a higher exchange rate. The major diversified miners, such as Anglo American and BHP, continue to benefit from high iron ore prices, which we think will prove unsustainable. Share prices of industrial companies with predominantly foreign operations have also been resilient, as they are generally exposed to stronger economies and again, the share prices in rands have benefited from the weaker exchange rate. Richemont and Bidcorp are examples here, but most notable are of course Naspers and Prosus.

The bulk of the value of Naspers and Prosus comes from Chinese internet company Tencent. The Chinese economy is recovering strongly following severe lockdowns earlier this year. COVID-19 has accelerated structural trends that were already in place. This has benefited Tencent in areas like mobile games, migration to the cloud and digital payments. While the Tencent valuation is not low, South African investors through Naspers are effectively buying the company at a sizeable discount. Naspers continues to be the largest holding in the portfolio, although we are still underweight compared to the index. Naspers and Prosus have a combined weight of 21% in the ALSI, which is a bigger weight than we would want to a single business.

The strong performance of the above areas of the market has masked the poor share price performance of financials and domestically focused industrials. We are finding many extremely attractive opportunities among South African companies, for example retailers and banks. SA retailers have, of course, been negatively impacted by the lockdown periods, but this is captured in current share prices. Foschini and Woolworths, for example, are trading at less than 10 times our estimate of normal earnings. The situation for SA banks is similar: The immediate earnings outlook is negative with rising bad debts and a weak economy. However, offsetting this are valuations, which were last this low during the 2007-2008 global financial crisis, or the 1980s before that.

Previous periods of similarly low valuations, such as 2001-2003 for retailers or 2009 for banks, led to very high subsequent returns for investors who were brave enough to buy amid the uncertainty. In both the case of retailers and banks, it is hard to know when earnings of these businesses will recover and start growing again. But when one is paying a sufficiently low price for a decent business, predicting exactly when a recovery will happen is less important. Benjamin Graham, the father of value investing, describes this principle as follows: "The function of the margin of safety is, in essence, that of rendering unnecessary an accurate estimate of the future". Despite the attractive current valuations of financials and domestic industrials, we have been cautious and selective in how we increase positions in these sectors, given the various risks. The largest positions in the Fund are still predominantly foreign businesses such as Naspers and British American Tobacco.

The Allan Gray Equity Fund returned 0.7% for the quarter. During the quarter we bought British American Tobacco and Sibanye-Stillwater, and sold Prosus and BHP. The foreign portion of the Fund contributed marginally to performance.

Management Company

Allan Gray Unit Trust Management (RF) Proprietary Limited (the 'Management Company') is registered as a management company under the Collective Investment Schemes Control Act 45 of 2002, in terms of which it operates 11 unit trust portfolios under the Allan Gray Unit Trust Scheme, and is supervised by the Financial Sector Conduct Authority ('FSCA'). The Management Company is incorporated under the laws of South Africa and has been approved by the regulatory authority of Botswana to market its unit trusts in Botswana, however it is not supervised or licensed in Botswana. Allan Gray Proprietary Limited (the 'Investment Manager'), an authorised financial services provider, is the appointed Investment Manager of the Management Company and is a member of the Association for Savings & Investment South Africa ('ASISA'). The trustee/custodian of the Allan Gray Unit Trust Scheme is Rand Merchant Bank, a division of FirstRand Bank Limited. Performance

Fund mandate

The Fund may be closed to new investments at any time in order to be managed according to its mandate. Unit trusts are traded at ruling prices and can engage in borrowing and scrip lending. The Fund may borrow up to 10% of its market value to bridge insufficient liquidity.

Unit price

Unit trust prices are calculated on a net asset value basis, which is the total market value of all assets in the Fund including any income accruals and less any permissible deductions from the Fund divided by the number of units in issue. Forward pricing is used and fund valuations take place at approximately 16:00 each business day. Purchase and redemption requests must be received by the Management Company by 14:00 each business day to receive that day's price. Unit trust prices are available daily on www.allangray.co.za

Fees

Permissible deductions may include management fees, brokerage, Securities Transfer Tax (STT), auditor's fees, bank charges and trustee fees. A schedule of fees, charges and maximum commissions is available on request from Allan Gray.

Total expense ratio (TER) and Transaction costs

The total expense ratio (TER) is the annualised percentage of the Fund's average assets under management that has been used to pay the Fund's actual expenses over the past one and three-year periods. The TER includes the annual management fees that have been charged (both the fee at benchmark and any performance component charged), VAT and other expenses like audit and trustee fees. Transaction costs (including brokerage, Securities Transfer Tax [STT], STRATE and Investor Protection Levy and VAT thereon) are shown separately. Transaction costs are a necessary cost in administering the Fund and impact Fund returns. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of financial product, the investment decisions of the investment manager and the TER. Since Fund returns are quoted after the deduction of these expenses, the TER and Transaction costs should not be deducted again from published returns. As unit trust expenses vary, the current TER cannot be used as an indication of future TERs. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Instead, when investing, the investment objective of the Fund should be aligned with the investor's objective and compared against the performance of the Fund. The TER and other funds' TERs should then be used to evaluate whether the Fund performance offers value for money. The sum of the TER and Transaction costs is shown as the Total investment charge ('TIC').
