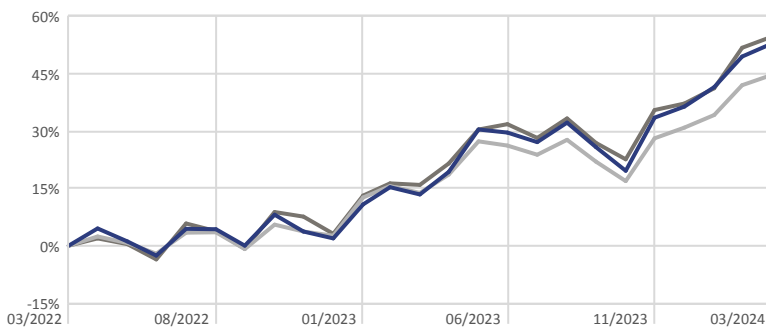
INVESTMENT OBJECTIVE

The BCI GinsGlobal Global Equity Index Feeder Fund aims to provide investors with long term capital growth.

INVESTMENT POLICY

The Fund aims to provide investors with long term capital growth. The portfolio will apart from assets in liquid form, invest solely in the participatory interests of the GinsGlobal Global Equity Index Fund, a sub-fund of GinsGlobal Index Funds (Mauritius) Limited Fund Scheme, domiciled in Mauritius. The underlying portfolio tracks a basket of equity markets. To the extent that the assets in the portfolio are exposed to exchange rate risk, the manager may enter into financial transactions for the exclusive purpose of hedging such exchange rate risk subject to the conditions.

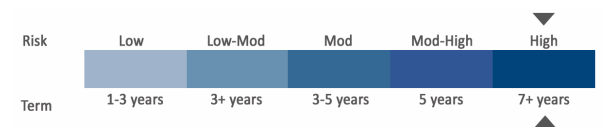
