INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve significant real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - High Equity funds over a full market cycle by maintaining meaningful exposure to growth assets like equities.

INVESTMENT PROCESS

The Fund invests across a range of assets including equities and interest bearing instruments, both domestically and offshore. The asset allocation is anchored at the long-term strategic allocation, but can be varied tactically to target outperformance of the benchmark by capitalising on signals of significant market mispricing. Where possible, a process of enhanced indexation is utilised within asset classes to deliver stable incremental alpha.

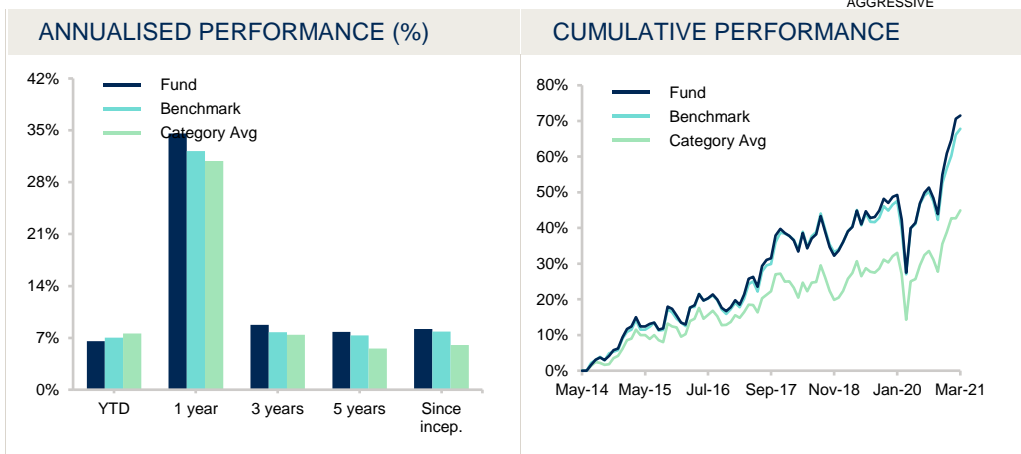
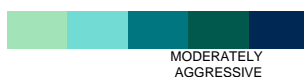
WHO SHOULD INVEST

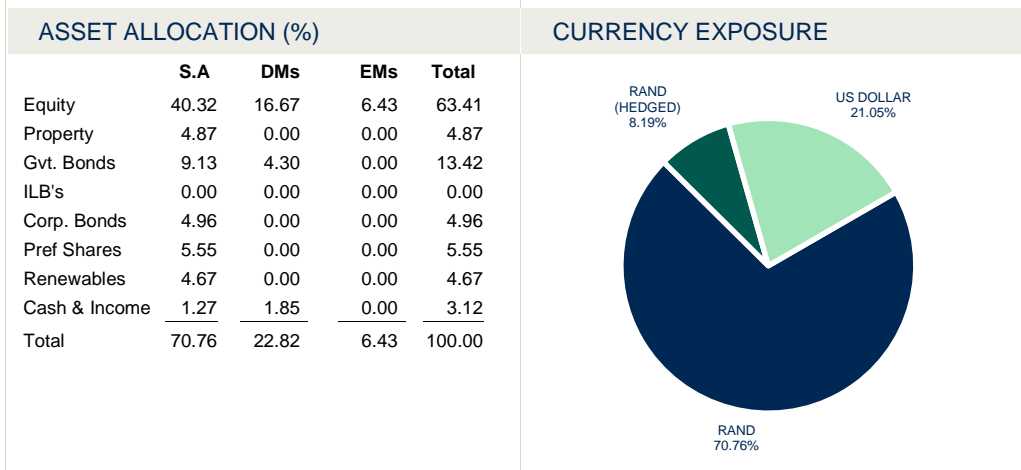
RISK INDICATOR DEFINITION

FUND COMMENTARY

The risk-on theme that is currently playing out in financial markets continued largely unabated, save for a few speed bumps introduced by rising volatility in the US Treasury market. The ongoing global recovery contributed to a decent month for local equities, with the FTSE/JSE All Share index returning 1.58%. The JSE Listed Property Index delivered 1.23%, while the FTSE/JSE Preference Share Index was the standout performer with returns of 2.26%. The BEASSA All Bond Index was the laggard – with a negative return of 2.54% - as rising US Treasury yields continued to exert upward pressure on local bond yields.

Looking abroad, economic optimism remains high in U.S. financial markets, buoyed by improving Covid trends and solid economic data. The passage of the \$1.9 trillion American Rescue Plan (ARP) added more fuel to the recovery, particularly in the near term, and the Fed seems committed to keeping a heavy foot on the accelerator for the foreseeable future. As such, there is a mainstream debate over inflation risks for the first time in many years. One could argue that the market is currently priced for an obstacle-free path of robust economic recovery, and another wave of Covid cases could potentially lead to another round of restrictions in parts of the U.S., something Europe has been dealing with again in recent weeks. That said, the broad economic outlook remains very positive looking forward, which fueled further steepening of the US Treasury curve in March. The combination of improved COVID-19 trends and vaccine distribution, new fiscal aid, and strong recent economic data has helped change the narrative in the bond market, sending long-end Treasury yields and inflation expectations higher.

The Fund continues to be well placed to benefit from opportunities that arise. Its increased exposure to risk assets continues to contribute positively to performance, while the non-linear exposure (long call options) to developed market bonds shielded the fund from rising global yields.

Contributors to performance: Local preference shares, local equities and the ZAR hedge contributed positively to performance as global economic recovery continued to power ahead.

Detractors from performance: Local bonds were the largest detractor, mainly due to foreign selling of local bonds due to rising US Treasury yields.

GLOSSARY

Annualised performance: Annualised performance show longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
